Submissions are open from the 1st October 2020, and close on the 15th March 2021
Please take at least three high definition photographs of your completed piece of work and email them to us by no later than the 25th March 2021. You can email your photographs to Vicky at educator@autismsouthafrica.org

Autism South Africa will pay for the courier costs initially – the art piece will remain with the artist, and after the auction, Autism South Africa will arrange for the courier to pick up the piece from the artist and deliver it to the buyer. Please ensure that your work is packaged appropriately to protect it during shipping.

This cost be included in the final sale price.

Autism South Africa will then retain the costs for shipping.

The auction will take place online on the 2nd April 2021

All money raised for an art piece will go directly to the artist

All money MUST be paid into Autism South Africa's bank account, once the funds have cleared, they will be paid into the artists account.

Art will not be shipped to the buyer until Autism South Africa has payment

In the unlikely event that a buyer does not pay for their art, the art piece will be shipped back to the artist.
